### Disclosure of share buybacks in the period from 28<sup>th</sup> October to 31<sup>st</sup> October 2024

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, as part of the share buyback programme authorized by the previously disclosed to the market on 15 May 2023 and 22 April 2024 ("Buyback programme"), in the period from 28<sup>th</sup> to 31<sup>st</sup> October 2024, it purchased no. 3,000 treasury shares at the weighted average price of Euro 3.0733 per share, for a total value of Euro 9,220.00
