**INFORMATIVA SU ACQUISTO AZIONI PROPRIE

Segrate, 13 gennaio 2025 - Arnoldo Mondadori Editore S.p.A. (codice LEI 815600049A1F9AFE6666) comunica di aver acquistato sul Mercato regolamentato Euronext Milan, nel periodo tra il 6 gennaio 2025 e il 10 gennaio 2025, complessive n. 52.500 azioni ordinarie (pari allo 0,020% del capitale sociale) al prezzo unitario medio di euro 2,0905341 per un controvalore complessivo di euro 109.753,04.

Tali operazioni sono state realizzate nell'ambito dell'autorizzazione all'acquisto di azioni proprie deliberata dall'Assemblea Ordinaria degli Azionisti del 24 aprile 2024 e in esecuzione del programma di acquisto esclusivamente a servizio dei Piani di Performance Share in essere, il cui avvio è stato approvato dal Consiglio di Amministrazione del 13 novembre 2024 (come da informativa resa in pari data anche ai sensi dell'art. 144-bis del Regolamento Consob 11971/99 e dell'art. 5 del Regolamento UE 596/2014).

DISCLOSURE ON THE PURCHASE OF TREASURY SHARES IN THE PERIOD 6 - 10 JANUARY 2025

Segrate, 13 January 2025 - Arnoldo Mondadori Editore S.p.A. (LEI Code 815600049A1F9AFE6666) announces the purchase on the Euronext Milan regulated market, in the period 6 - 10 January 2025, of no 52,500 ordinary shares (equal to 0.020% of the share capital) at an average unit price of € 2.0905341 for a total amount of €109,753.04.

These transactions were made under the authorization to purchase treasury shares approved by the Shareholders' Meeting of 24 April 2024, and as part of the purchase programme to service the Performance Share Plans underway, the start of which was approved by the Board of Directors on 13 November 2024 (as per the disclosure made on the same date also pursuant to Article 144 bis of CONSOB Regulation 11971/99, and to Article 5 of EU Regulation 596/2014).
