

MODIFICATION OF THE 2025 CORPORATE EVENTS CALENDAR

In particular, compared to what was previously announced on January 29, 2025, the Company will not participate in the EnVent Winter Conference - Westin Palace, originally scheduled for January 18, 2025, in Milan.

Through direct testimonials from the management teams of both companies involved, the event will illustrate the integration strategies between Mare Group and La SIA, with particular attention to industrial and technological synergies, the competitive advantages arising from the transaction, and the growth scenarios made possible by this combination.
