Milano, 28 aprile 2025 – Nell'ambito del programma di acquisto di azioni proprie, di cui all'art. 5 del Regolamento (UE) n. 596/2014 (la "**MAR**"), comunicato al mercato in data 4 marzo 2025 ed avviato in data 5 marzo 2025 per massime n. 7.700.000 azioni ordinarie (il "**Programma**") a servizio del "*Piano di Incentivazione di Lungo Termine 2021-2023*", del "*Piano di Incentivazione di Lungo Termine 2022-2024*", del "*Piano di Incentivazione di Lungo Termine 2023-2025*" (limitatamente ad una quota di azioni da attribuire ad un beneficiario "*good leaver*", ai sensi del Regolamento del Piano), del "*Piano di Restricted e Matching Shares*" e del Secondo Ciclo (2024) del "*Piano di Azionariato diffuso 2023-2025, rivolto alla generalità dei dipendenti*" (congiuntamente, i "**Piani di Incentivazione Azionaria**"), MAIRE S.p.A. THE TREASURY SHARE BUYBACK PROGRAM DEDICATED TO GROUP'S SHARE INCENTIVE PLANS HAS BEEN COMPLETED

Milan, 28 April 2025 – Under the buyback program of treasury shares referred to Art. 5 of the Commission Delegated Regulation (EU) no. 596/2014 (the “**MAR**”), announced to the market on 4 March 2025 and launched on 5 March 2025 for a maximum number of 7,700,000 ordinary shares (the “**Program**”) dedicated to the “2021-2023 Long-term Incentive Plan”, the “2022-2024 Long-term Incentive Plan”, the “2023-2025 Long-term Incentive Plan” (limited to a stock of shares to be granted to a “good leaver” beneficiary, pursuant to the Plan Regulation), the “*Restricted Stock and Matching Shares Plan*” and the Second Cycle (2024) of the “*Employees Share Ownership Plan 2023-2025 dedicated to all employees*” (jointly, the “**Share Incentive Plans**”), MAIRE S.p.A. (the “**Company**” or “**MAIRE**”) announces – according to the provision and for the purpose of Article 2 paragraph 3 of the Commission Delegated Regulation (EU) 1052/2016 of 8 March 2016 (the “**1052 EU Regulation**”) – to have acquired on the Euronext Milan Market (EXM) organized and managed by Borsa Italiana S.p.A., in the period from 22 April 2025 to 25 April 2025 included, total no. 769,641 of treasury shares (corresponding to 0.234% of the total number of ordinary shares), at a weighted average price of Euro 7.993 for a total counter-value of Euro 6,151,744.04.

It should be noted that all the Treasury Shares dedicated to the Share Incentive Plans have been purchased; therefore, the related Program has been completed.

On the basis of information provided by Intesa Sanpaolo S.p.A., the authorized intermediary in charge of carrying out the buyback mentioned in the present press release, here below is a summary of the daily operations, in aggregate form:
