THE CY4GATE GROUP CONSOLIDATES AND STRENGTHENS CORPORATE GOVERNANCE TO MEET NEW BUSINESS CHALLENGES IN THE SECTOR

ENRICO PERUZZI APPOINTED EXECUTIVE CHAIRMAN

Rome, 09 June 2025 - CY4GATE (CY4.MI), a national and European player in cyber security and cyber intelligence, announces that the Board of Directors held today has appointed by co-optation, subject to the favourable opinion of the Appointments and Remuneration Committee, and with resolution approved by the Board of Statutory Auditors, Mr. Enrico Peruzzi - whose curriculum vitae is available on the Company's website at https://www.cy4gate.com/en/company/governance/ as new Director, following the resignation tendered, with immediate effect, by Director Prof. Alberto Sangiovanni Vincentelli, due to unforeseen professional commitments.

The Board of Directors also resolved on the appointment of Enrico Peruzzi as the new Executive Chairman of the Company. Enrico Peruzzi succeeds Domitilla Benigni, who will maintain his position as Director and will assume the role of Chairman of the Strategic Committee - committee not envisaged by the Corporate Governance Code voluntarily established by the Company and previously chaired by Prof. Vincentelli - ensuring continuity in the board structure and full support in the pursuit of the Company's strategic development objectives.

Consequently, as part of the aforesaid overall reorganisation of corporate governance, the Board of Directors resolved to reorganise the powers, granting the new Executive Chairman, in addition to the powers envisaged by law and the Articles of Association, powers of representation of the Company, as well as supervision and strategic direction. including operational proxies relating to the conduct of Cy4Gate's business.

Enrico Peruzzi is a Top Executive with thirty years of proven experience who has held key roles in the Aerospace & Defence sector. With his entry into the corporate governance structure, the Group will be able to count on the contribution of a long-standing manager, who has worked in structured, national and international contexts, in transversal and strategic roles of increasing complexity, bringing precious skills that within the company will contribute to further consolidate its overall efficiency, growth and competitiveness in the markets, with particular reference to the Defence sector.

The Board of Directors and the entire management express their strong appreciation for the work carried out by the outgoing Chairman in the knowledge that the Company will continue to benefit from his valuable contribution as Chairman of the Strategic Committee. The Board also expresses its heartfelt thanks to Prof. Vincentelli for his qualified contribution since the Company's foundation and best wishes for a successful work to the new Executive Chairman.
