S.p.A. as part of its treasury share buyback programme (the Programme) – which was launched on 8 May 2025 implementing the 17 April 2025 Shareholders' Meeting resolution – in the 8 DECEMBER –12 DECEMBER 2025 period, purchased 24,000 treasury shares, (equal to 0.0939% of the share capital), at an average weighted price of € 9.5972, for a total value of € 230,333.05.
