- planning and development of activities in the reference markets;
- tenders and award procedures;
- design, verifications, construction management and safety;
- organization of the internal structure and development of skills.

Nicolò Caffo brings to Franchetti **solid international experience** in infrastructure business management and transformation and growth processes. He has held *senior executive roles*, including General Manager of Ecorodovias in Brazil (Gavio/ASTM Group), where he coordinated operations, engineering, development and innovation in complex, capital-intensive environments, during which period he also worked with the Franchetti Group's services.
