UNIDATA LAUNCHES ITS INTERNATIONAL EXPANSION IN THE UNITED ARAB EMIRATES, THANKS TO A COMMERCIAL AND STRATEGIC PARTNERSHIP AGREEMENT WITH SERDAL HOLDING, A COMPANY BASED IN ABU DHABI

THE PARTNERSHIP MARKS THE ENTRY OF THE UNIDATA GROUP INTO A RAPIDLY GROWING AREA, CHARACTERIZED BY SIGNIFICANT INVESTMENTS IN DIGITAL INFRASTRUCTURE, DATA CENTERS AND ARTIFICIAL INTELLIGENCE

Roma, 27 January 2026 – Unidata S.p.A. During the visit, Chairman and CEO **Renato Brunetti**, together with Chief Financial and Legal Officer **Roberto Giacometti** and Innovation and Research Development Director **Patrizio Pisani**, also had the opportunity to gain a **comprehensive overview of the UAE's development strategies**. This was also achieved through a meeting with the **Italian Ambassador to the United Arab Emirates**, who expressed his full willingness to support the company in strengthening local institutional and industrial relations, encouraging the organization of further meetings with key players in the digital sector.
