



**SOMEC: OXIN, PART OF THE TALENTA DIVISION, SECURES A RECORD-BREAKING 53 MILLION EURO CONTRACT FOR THE KITCHEN AND CATERING AREAS OF TWO NEW CRUISE SHIPS**

**The contract will cover a total surface area of approximately 14 thousand square metres and will also include an on-board brewery.**

San Vendemiano (TV), February 10, 2026 - Somec S.p.A. (Euronext Milan: SOM), specialized in the engineering, production and installation of complex turnkey projects in the civil and naval engineering sector, announced that a new contract for a total worth of 53 million euro has been awarded to its *Talenta Professional Kitchen Systems and Products* division, through its subsidiary Oxin.

The contract concerns the turnkey supply of the galley, pantry, catering, and bar areas for two latest-generation cruise ships currently under construction at a leading Italian shipyard and intended for a German cruise company that is part of a major international group. Both units are designed to offer a comprehensive range of services, with the distinctive modernity and “resort” style of the on-board concept typified by the food & beverage and restaurant areas.

The solutions developed by Oxin are characterized by a high level of integration between space design, operational flows and system engineering - supporting the operational needs of the staff and excellence standard of the food and beverage offering. The contract supply covers a total area of approximately 14,000 square metres, equally distributed between the two units, and includes the construction of a dedicated production line for on-board beer brewing - a solution that requires special skills and a high level of flexibility to meet specific customer requirements.

The vessels are scheduled for delivery between 2030 and 2031, with economic returns expected between 2027 and 2030.

This is the highest-value contract ever acquired in Oxin's twenty-two years in business.

Oscar Marchetto, Somec Chairman, pointed out that: *“In the cruise industry's newbuilding programs, food and beverage systems play a central role in the companies' offerings, with increasingly challenging operational impacts and technical requirements - which can only be met through consolidated specialist skills and a solid design expertise. In this scenario, this contract is yet another significant achievement for Oxin and the entire Talenta division, made possible by the commitment and professionalism of the team of internal experts involved. Contracts like this contribute to strengthening Oxin's leading position in the field of turnkey professional on-board kitchen supply, as well as the group's order portfolio visibility, which is increasingly long-term oriented”.*
