("**BF**" or the "**Company**") has announced that increased voting rights for 6,757,000 ordinary shares came into effect on the 1<sup>st</sup> of March 2026, bringing the total number of shares with increased voting rights is 106,254,078, pursuant to Article 127-quinquies of the Consolidated Law on Finance and in accordance with the provisions of the Articles of Association and the Regulations on Increased Voting Rights adopted by the Company on 26 January 2022, which can be found on the Company's website in the "Investor Relations – Voto Maggiorato" section ([https://www.bfspa.it/it/investor\\_relations/voto-maggiorato](https://www.bfspa.it/it/investor_relations/voto-maggiorato)).
