

**NOTICE ON THE EXECUTION OF THE SHARE BUYBACK PROGRAMME DURING THE PERIOD BETWEEN 2 AND 6 MARCH 2026**

**Jolanda di Savoia (FE), 9 March 2026** – With regard to the implementation of the share buyback programme disclosed to the market on 9 January 2026, B.F. S.p.A. (the “**Company**”) communicates – in accordance with the provisions of article 2, paragraph 3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 (the “**EU Regulation 2016/1052**”) – the purchase, on the Euronext Milan Market organized and managed by Borsa Italiana S.p.A., during the period between 2 March 2026 and 6 March 2026, both dates included, of 7,755 shares (equal to 0.0030% of its share capital), at a weighted average price per share of Euro 4.3975, for a total amount of Euro 34,102.35.

Based on the information provided by the intermediary appointed to execute the purchases, here below a summary of the transactions on a daily basis:
