

NOTICE ON THE EXECUTION OF THE SHARE BUYBACK PROGRAMME DURING THE PERIOD BETWEEN 9 AND 13 MARCH 2026

Jolanda di Savoia (FE), 16 March 2026 – With regard to the implementation of the share buyback programme disclosed to the market on 9 January 2026, B.F. S.p.A. (the “**Company**”) communicates – in accordance with the provisions of article 2, paragraph 3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 (the “**EU Regulation 2016/1052**”) – the purchase, on the Euronext Milan Market organized and managed by Borsa Italiana S.p.A., during the period between 9 March 2026 and 13 March 2026, both dates included, of 6,400 shares (equal to 0.0024% of its share capital), at a weighted average price per share of Euro 4.3795, for a total amount of Euro 28,029.00.
