Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, in the period from 30<sup>th</sup> March to 02<sup>nd</sup> April 2026, it purchased no. 9,000 treasury shares at the weighted average price of Euro 3.4278 per share, for a total value of Euro 30,850.16.
