## Disclosure of share buybacks in the period from 25<sup>th</sup> to 29<sup>th</sup> May 2026

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, in the period from 25<sup>th</sup> to 29<sup>th</sup> May 2026, it purchased no. 8,000 treasury shares at the weighted average price of Euro 4.1057 per share, for a total value of Euro 32,845.83.
