(codice LEI 81560017CF8066680595) che investe nelle eccellenze imprenditoriali, comunica di aver acquistato sul mercato Euronext Milan, nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea del 29 aprile 2026 (già oggetto di informativa anche ai sensi dell’art. 144-*bis*, comma 1 lettera b), del Regolamento Consob 11971/99 e dell’art. 132 del D.Lgs. n. 58/98) nel periodo dal 1° giugno 2026 al 5 giugno 2026 n. 92.502 azioni ordinarie (pari allo 0,050% del capitale sociale) al prezzo medio ponderato di euro 8,7274 per un controvalore complessivo di euro 807.305,64.
