

## SOMEC SECURES 60 MILLION EURO MARINE GLAZING SUPPLY FOR NEWBUILD CRUISE VESSELS

The *Horizons* Business Unit has consolidated and expanded a multi-year programme running through 2031 with a leading Finnish shipyard for the supply of integrated marine glazing systems on one of the world's most ambitious shipbuilding series.

**Somec's Chairman Oscar Marchetto has commented: "*Securing continuity across multiple consecutive sister ships within the same series is viewed as the most tangible form of recognition groupwide.*"**

San Vendemiano (Treviso), June 15, 2026 – Somec S.p.A. (Euronext Milan: SOM), specialising in the engineering, manufacturing and installation of complex turnkey projects for the civil and naval sectors, announced that it has signed contracts with a leading Finnish shipyard totalling 60 million Euro. The contracts, awarded to the *Horizons: Engineered Systems for Naval Architecture and Building Façades* BU, covers the turnkey supply of integrated marine glazing systems for three newbuild cruise vessels destined for a leading international cruise brand.

The agreement further strengthens and expands an existing partnership following the conversion of two options into firm orders - previously disclosed to the market in July 2025 (see the relevant press release) - and the addition of a third new vessel.

The project, among the most complex ever awarded to the Horizons Business Unit, encompasses the turnkey supply of the complete balcony system, the vertical motor-driven opening windows for the Infinity Cabins (patented<sup>1</sup> by Somec), the high-deck forward glazing and window systems, as well as the architectural glazing for various public areas.

These cruise vessels are part of one of the largest-scale series ever designed, conceived as self-contained floating urban microcosms and featuring multi-deck vertical spaces, indoor promenades, architectural-scale public areas with immersive entertainment venues, and extraordinarily extensive glass domes.

The project will be executed between 2027 and 2031, with the related financial impact distributed across the entire duration of the programme.

This contract is in addition to those previously disclosed on 7 May 2026 and 19 May 2026, valued at 38 million Euro and 56 million Euro, respectively (see the relevant press releases).

Oscar Marchetto, Chairman of Somec, stated: "*We are pleased to reaffirm our position as a partner in some of the most ambitious shipbuilding programmes currently active worldwide, with the complexity of the projects entrusted to Somec fully reflecting their scale. Vertical motor-driven opening systems, architectural glazing spanning diverse spatial configurations, and bespoke technical solutions engineered for vessels that consistently set new design benchmarks: this is the exact arena where the Horizons Business Unit's expertise truly shines. In this regard, securing continuity across multiple consecutive sister ships within the same series is viewed as the most tangible form of recognition groupwide.*"
