CIRCLE Group secures new contracts worth approximately €110,000 for the digital transformation of intermodal processes

New developments to the MILOS® MTO platform will support more integrated, automated, and traceable management of rail and logistics flows

Milan, June 16, 2026

Circle S.p.A. (“**Circle Group**” or the “**Company**”) - an innovative SME listed on the Euronext Growth Milan market, and the parent company of the group of the same name specialising in process analysis and the development of solutions for innovation and digitalisation in the port and intermodal logistics sectors, as well as in international consultancy on Green Deal and energy transition issues, announces that, over the past few weeks, it has secured new contracts from a **leading terminal operator** and MTO, active in container traffic management and the development of intermodal rail logistics, for a total value of approximately **€110,000**.

The activities concern the evolution of the proprietary **MILOS® MTO** platform, a component of the digital suite developed by Circle for the management of multimodal transport processes, and are part of a collaborative effort aimed at supporting the digitalization and streamlining of operational activities related to rail and intermodal traffic.

The new developments involve expanding the platform’s capabilities with the aim of improving information exchange among the various stakeholders in the logistics chain, simplifying operational processes, and enhancing the quality and availability of data to support decision-making.

Areas of focus include digital integration with rail operators for the automated exchange of train-related information, the setup of dedicated environments for testing, training, and operational support for deployment, as well as additional functional enhancements designed to support users’ daily operations.

The project also includes developments to support administrative and control processes, the management of information related to rail cars, dedicated access for certain categories of operators, and the improvement of transport documents. The overall objective is to promote greater information continuity between terminals, rail operators, trucking companies, and



other entities involved in intermodal flows.

“The acquisition of these new contracts confirms the effectiveness of our development strategy for solutions dedicated to the digitalization of intermodal logistics. With the MILOS® MTO suite, we continue to invest in process integration and the leveraging of operational data, providing the market with increasingly effective tools to improve efficiency, traceability, and collaboration among the various players in the supply chain” – stated Luca Abatello, President and CEO of CIRCLE Group.

Thanks to these new contracts, Circle, in line with its “Connect 4 Agile Growth” plan, is consolidating its role in supporting the digitalization of port operations and intermodal logistics, confirming the central importance of modular and interoperable solutions to support the evolution of supply chains and logistics corridors.
