Franchetti Group: ECR consolidates growth in Brazil with new infrastructure contracts and takes part in São Paulo's new road link awarded to Acciona**The Group's backlog exceeds €100 million, strengthening the visibility of future revenues**

Arzignano (VI), Italy, 03 July 2026 – **Franchetti S.p.A.** (Ticker BIT: FCH), a multinational company specializing in advanced diagnostic solutions, digitalization and predictive maintenance of infrastructure, announces that the **ECR Group**, made up of the Brazilian companies ECR Engenharia Ltda. and ECR Tecnologia e Engenharia Ltda., of which Franchetti acquired 55% of the share capital in March 2026 through a controlled company incorporated under Brazilian law, has further strengthened its order backlog in Brazil through **the acquisition of new contracts in the road infrastructure sector**.

This commercial momentum confirms Brazil's strategic role in the Franchetti Group's international growth path and helps bring the **Group's consolidated backlog above €100 million**, significantly strengthening the visibility of future revenues.

Among the new activities acquired by ECR, particular note goes to its involvement in the project for the construction of the new road link between Avenida Jornalista Roberto Marinho and Rodovia dos Imigrantes, in the southern area of the city of São Paulo. The project has been awarded to **Acciona**, a multinational group based in Spain among the leading global players in the construction and management of large infrastructure, which represents a particularly important client for the Franchetti Group, also in relation to its international development path and the strengthening of its presence in foreign markets.

The project, with an estimated overall budget of **around R\$2.4 billion** - equivalent to more than €400 million at the current exchange rate - falls under Goal 36 of the São Paulo city's 2025-2028 Goals Program and represents one of the main infrastructure redevelopment projects in the southern area of the Brazilian metropolis.

As part of the assignment, ECR will be involved in **design activities and specialized engineering services** for three viaducts and two tunnels included in the project, combining vertical technical expertise in structural engineering works with the use of advanced digital methodologies and tools. The design phase of the works is expected to last **around 16 months** and will also be carried out using Building Information Modeling (BIM) methodology, supporting an integrated management of the infrastructure's technical, design and documentation data.

ECR's involvement will extend to technical support activities throughout the construction

In this context, Franchetti will support its Brazilian subsidiary by making available its specialized expertise and the proprietary technologies developed by the Group, with particular reference to the digitalization of engineering processes, the structured management of infrastructure data, BIM integration, and the evolution towards digital models of the works that can also be used for future digital inspection, automated diagnostics and predictive maintenance activities.

The Group's approach in fact aims to transform traditional engineering activities on bridges, viaducts and tunnels into a technologically integrated process, in which design, data, digital models, inspections and predictive analytics can all contribute to managing the infrastructure across its entire life cycle. This positioning allows Franchetti to combine ECR's engineering expertise with a proprietary technology platform geared towards scalability, process standardization and the creation of recurring value in the management of infrastructure works.

The acquisition of new contracts by ECR confirms the **solidity of the Franchetti Group's positioning in the Brazilian market** and represents a further step in building an international platform specialized in advanced infrastructure management, capable of combining engineering expertise, proprietary technology, BIM, data, digital tools and applied intelligence in support of the entire life cycle of the works.
