(LEI code no. 81560017CF8066680595) which invests in excellent entrepreneurial companies, in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 29, 2026 approval (already announced in according to article 144–bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999 and article 132 of Legislative Decree no. 58/98) of n. 229,863 TIP S.p.A. ordinary shares (equal to 0.125% of share capital) throughout July 20, 2026, to July 24, 2026, at a weighted average price of 9.3391 Euro, at the countervalue of 2,146,703.03 Euro.
