OVS S.p.A. (OVS.MI) announces that, during the period between 31 August 2026 and 4 September 2026, it purchased no.240,843 ordinary shares on Euronext Milan (equal to 0.094% of the share capital) at an average price of 5.8752 Euro, for a total consideration of 1,415,010.31 Euro.

The transactions were carried out in implementation of the share buyback program launched on 1 June 2026, pursuant to the authorization approved by the Shareholders' Meeting on 29 May 2026.
