OVS S.p.A. (OVS.MI) announces that, during the period between 14 September 2026 and 18 September 2026, it purchased no. 309,213 ordinary shares on Euronext Milan (equal to 0.121% of the share capital) at an average price of 5.4665 Euro, for a total consideration of 1,690,320.03 Euro.

The transactions were carried out in implementation of the share buyback program launched on 1 June 2026, pursuant to the authorization approved by the Shareholders' Meeting on 29 May 2026.
